In return, the Climsoft Project shall not use Your Contributions in a way that is contrary to the public benefit and the interests of users of Climsoft CDMS and its associated products. Except for the licence granted herein to the Climsoft Project and recipients of software distributed by the Climsoft Project, You reserve all right, title, and interest in and to Your Contributions.

1. Definitions.

"You" (or "Your") shall mean the copyright owner or legal entity authorised by the copyright owner that is making this Agreement with the Climsoft Project. For legal entities, the entity making a Contribution and all other entities that control, are controlled by, or are under common control with that entity are considered to be a single Contributor. For the purposes of this definition, "control" means the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise.

"Contribution" shall mean any original work of authorship, including any modifications or

additions to an existing work, that is intentionally submitted by You to the Climsoft Project for inclusion in, or documentation of, Climsoft and its associated products. For the purposes of this definition, "submitted" means any form of electronic, verbal, or written communication sent to the Climsoft Project or its representatives, including but not limited to communication on electronic mailing lists, source code control systems, and issue tracking systems that are managed by, or on behalf of, the Climsoft Project for the purpose of discussing and improving Climsoft, but excluding communication that is conspicuously marked or otherwise designated in writing by You as "Not a Contribution".

"Working Day" shall mean a day other than a Friday and/or Saturday and/or Sunday or public holiday in a relevant legislation.

2. Grant of Copyright Licence.

Subject to the terms and conditions of this Agreement, You hereby grant to the Climsoft Project and to recipients of software distributed by the Climsoft Project a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable copyright licence to reproduce, prepare derivative works of, publicly display, publicly perform, sublicense, and distribute Your Contributions and such derivative works under the terms of the GNU General Public Licence ("GPL"), the text of which may be found at:

You agree and acknowledge that the Climsoft Project and its licensees may sublicense and distribute your Contributions under any version of the GPL approved by the Free Software Foundation.

3. Intellectual Property Infringement.

If any third party makes any claim against You or any other entity, alleging that your Contribution, or the Work to which you have contributed, infringes the intellectual property rights of that third party, then You shall inform the Climsoft Steering Group within 5 Working Days of such claim in order for the Climsoft Steering Group to take all appropriate action it deems necessary in relation to the claim.

4. Your entitlement to enter into this Agreement

You represent that you are legally entitled to grant the above licence. If your employer(s) has rights to intellectual property that you create that includes your Contributions, you represent that you have received permission to make Contributions on behalf of that employer, that your employer has waived such rights for your Contributions to the Climsoft Project, or that your employer has executed a separate Licence Agreement with the Climsoft Project.

5. Originality of Contributions

You represent that each of Your Contributions is Your original creation (see section 7 for submissions on behalf of others). You represent that Your Contribution submissions include complete details of any third-party licence or other restriction (including, but not limited to, related patents and trademarks) of which you are personally aware and which are associated with any part of Your Contributions.

6. Provision of support
